#### CONTINUING OUR MISSION DURING THE COVID-19 PANDEMIC AND A NATIONWIDE LOCKDOWN

In view of the COVID-19 Pandemic, a nationwide lockdown was announced by the Government of India w.e.f. 25th March 2020. While COVID-19 is impacting the entire population, Persons with Disabilities (PwDs) are more vulnerable to the disease due to their physical, sensory and cognitive limitations.

While all vocational training classes and therapy sessions have been conducted online since 21<sup>st</sup> March 2020, ASRA Head Quarter opened its doors and conducted vocational training classes and therapy sessions in its physical location from 11th Feb 2021. However, due to a sudden spike in COVID cases, the city underwent another lockdown and vocational training classes & therapy sessions have had to be conducted online once again since 11th April 2021.

ASRA has continued working towards its mission digitally in the form of online sessions in Education, Special Education, Therapy, Vocational trainings, Recreation Activities, Counseling & Awareness and so on.

On-ground, children are being provided with study material and immunity boosters and essentials have been distributed to Persons with Disabilities (PwDs) on a need-based feedback.

## AWARENESS GENERATION AND DISTRIBUTION OF ESSENTIAL ITEMS TO PERSONS WITH DISABILITIES OF ADOPTED SLUM COMMUNITIES DURING COVID-19 CRISIS

**During the first wave of COVID-19 pandemic, 2493 PwD** beneficiaries across **68 communities** have been provided with essential items / relief packages from June 2020 to March 2021. As the COVID cases had risen due to second and much stronger wave of COVID 19, lockdown was again imposed in Delhi w.e.f. 17<sup>th</sup> April 2021 to 15<sup>th</sup> July 2021 (Partially Open). ASRA once again contacted its beneficiaries to do needs assessment survey and to know their primary needs. Several beneficiaries were struggling for food and to meet their basic daily necessities. It was decided to once again provide essential items / relief packages to the most needy PwD beneficiaries. During the quarter under report, **582 PwDs from 16 communities** were provided with essential items / relief package to meet their daily needs.

## DISTRIBUTION OF EDUCATION, NUTRITIOUS FOOD / IMMUNITY BOOSTER, PERSONAL HYGIENE, THERAPEUTIC KITS AND ESSENTIAL FOOD KIT TO THE CHILDREN UNDER EDUCATION, SPONSORSHIP AND AIRTC PROGRAMS

**During the first wave of COVID-19 pandemic, total 924 children were provided with study material** such as notebooks, registers, pencils, pens, erasers, drawing books, colours and 'Nutritious Food' / Immunity Boosters like porridge and dry flakes from June 2020 to March 2021.

An outcome of the CBR survey conducted during the quarter suggested that the children under the Education Program of ASRA needed to be kept engaged meaningfully on daily basis. Their health, hygiene and therapeutic needs were also important and had to be addressed.

Accordingly doorsteps distribution of **'Education Kits'** and **'Nutritious Food'** was initiated based on the teachers' feedback which was duly verified by the Rehab / Social workers and CBR Coordinators. During the quarter under report, **241 children** of Education & sponsorship program were provided with **'Education Kits'** and **'Nutritious Food'** (Immunity Boosters). **41 children of AIRTC were provided with five kits.** 

#### The Five Kits contained the following items:

- The Education Kit contained the following items:
  - Pencil, eraser, drawing board, magnetic letters, color tape, glitter sheets, origami sheets, glaze sheets, ice-cream sticks, cotton rolls, chart papers, Fevicol and A4 color sheets.
- The Nutritious Food / Immunity Boosters Kit contained the following items:

• Kaale chane, chocos, porridge, mix pulses, soya chunks, dry flakes, roasted nuts, jaggery, biscuit and oats. The **Personal Hygiene Kit** contained the following items:

- Hair oil, dettol soap, tooth brush, toothpaste, shoes, socks, handkerchief, masks and water bottle
- The **Therapy Kit** contained the following items:
  - Colorful light balls, smiley balls, squeezing balls, wooden hammer game, wooden sewing, puzzles, aiming game, cube, beads, clay, respirometer and weight cuffs.
- The Essential Food Item / Ration contained the following items:
  - Rice, sugar, salt, oil, soap, pulses, wheat flour, turmeric and face mask.

### ASRA INTERVENTION, RECREATION AND THERAPY CENTRE (AIRTC) for children with special needs

While the AIRTC remained physically shut due to lockdown, 34 children with special needs have availed special education classes via 3127 video / voice calling sessions during the year from April 2020 to March 2021.

As the AIRTC remains closed due to second wave of COVID-19 pandemic, the children continue to take their online education and therapy sessions during the quarter under report. The children have different types of disabilities, predominantly intellectual disabilities associated with physical impairments. Some children also have speech & hearing impairments. Following is the gender wise and community area wise classification of children enrolled in AIRTC during the quarter under report:


#### Online Special Education and Therapy Sessions of AIRTC children

- The AIRTC children are presently divided into 3 online groups on the basis of their IQ and disability with two groups having 11 children each and one group having 12 children.
- One to one online academic session designed according to Individual needs is being provided by the Special Educators to AIRTC children every Monday to Friday from 10.30 am till 2.30 pm. Parents are also guided during the sessions.
- Worksheets of academics i.e. Hindi, English, Maths and Art & Craft are prepared by the Special Educators and then forwarded to the parents. These worksheets are designed on the basis of children's IQ level and disability.
- Therapy plans for each AIRTC student is made according to the need and disability of the child.







## **Success Stories**

# TABISHStudent of ASRA Intervention, Recreation and Therapy Centre (AIRTC)

My name is Rajiya Khatun. I live in Bharat Vihar. My husband is an electrician. I have three sons and one daughter. My two sons are differently abled, one is mentally disabled as well as physically disabled. My second son is Tabish who is not able to speak. I took treatment for him from Lady Harding hospital, later he took treatment from AIIMS Hospital as well. The doctors told me that he is a differently abled child. I do not take my child alongwith me anywhere. It is very difficult going to the market because Tabish disturbs me a lot. I feel ashamed when I go alongwith him. One day I met Noorjahan madam at ASRA CBR community center and she told me that this organization helps differently abled children. She asked me to send Tabish at the center for his education. Then I started sending him at the ASRA center. After connecting with ASRA CBR Program. I got help in making his



disability certificate, railway pass, and pension etc. This has helped me in improving my financial status for treatment of Tabish. Previously I was not aware of any of these facilities provided by Government, for this kind of differently abled children. When ASRA did not have its own school, at that time I sent Tabish to another special school for his education. He learnt sitting and eating from there only. In 2018 ASRA opened their own school and I got him admitted in AIRTC. ASRA's CBR workers also guided me to avail all government facilities for my second son also. After attending AIRTC, I found a major change in Tabish's behavior. Now he is able to do his homework by himself. At school all teachers do take care of him very well. He is getting his regular physiotherapy exercises in ASRA. The fee is also very nominal at AIRTC School. When he goes to the school there is a peace maintained at home, also after coming from school he opens his homework books and starts doing it by himself. Since last one year he did not go to the school and is taking his online classes from AIRTC. Although the lockdown disturbed our financial status due to less work, during this critical time ASRA also provided us with help through providing Ration Kit. They helped as with the stationary material for Tabish's education at home. We got copy, pencil, eraser, drawing books and lots of other education material. During this time the school fees was also reduced to half. Many ASRA Team members visit us in order to instruct us for precautionary measures we should take during this Covid-19 time. I feel very happy as I am connected with this kind of organisation. All the ASRA people are very hardworking. They do not charge anything from us if we cannot pay. It is very difficult to find this kind of organization in this time.

I want this covid-19 situation to end soon so that Tabish can start his education and can go to school regularly as he disturbs us a lot at home, he usually stays fine due to the medicine he takes regularly. As soon we stop his medication he starts disturbing us. He does not eat his food regularly so I want him to go to school. — Ms. Rajiya Khatoon (Mother of Tabish)

#### GOLU

#### Sponsored CwDs

My name is Meena. I have three sons and all three sons are intellectually challenged. I live in Matiala Village, Pappankalan community. Their father is a rickshaw puller. I am home maker. I know ASRA since last 11 years. Before I got to know about ASRA, I was very disturbed regarding my eldest son namely Golu. Golu did not receive any kind of Government benefits. Then one of my relative told me about ASRA organization. I got connected with ASRA CBR Program. I got my eldest son enrolled in ASRA Education center at Pappankalan community in 2009. As soon as he started going to the center, he learnt how to sit at one place for a long time. I have realized that I am at the right place now. Golu got sponsorship from ASRA for admission in a special school. All expenses of that school was incurred by the ASRA



organization. Staff of ASRA also helped me in availing his disability certificate, pension and Rail Pass alongwith the e-ticket card. I am whole heartedly thankful to ASRA and due to ASRA, Golu started getting disability pension as well which actually improved my financial status. It was very difficult for us to hold the household expenses, only on the basis of the earning of my husband. I can see an intellectual change in Golu after he started going to the special school. Now he is little independent, he is working at a shop and from that also we earn something. Again I am thankful to ASRA. — **Ms. Meena (Mother of Golu)**

## **UPDATE ON ONGOING PROGRAMS**

### **COMMUNITY BASED REHABILITATION (CBR)**

During the first wave of COVID-19 pandemic, i.e. from April 2020 to March 2021, ASRA had provided information regarding COVID-19 disease and its symptoms and preventions to PwD beneficiaries through 4967 Video/Voice calls.

At a time when physical distancing has not only become an accepted but also a mandatory norm for survival against COVID-19, ASRA CBR team is using the means of telecommunication to stay connected with its beneficiaries in the communities. The CBR staff is making hundreds of calls every day to keep themselves abreast about the wellbeing, medical condition and other needs of the families. The team is providing information about the initiatives taken / special schemes provided by the Central and State Governments for their welfare. They also counsel them about the safety and preventive measures around COVID–19 and orient them on COVID-19 symptoms, spread and its precautions.

- a. Individual & Group counseling: Briefing beneficiaries about the basic protective measures against COVID-19.
  - ASRA CBR Team is constantly providing information to PwDs / CwDs about the basic steps for the prevention of COVID-19 as per the guidelines given by WHO and Ministry of Health, Government of India.
  - Beneficiaries and their families are told about the Do's and Don'ts.
  - ASRA CBR Team always tries to participate in the implementation of Government Initiatives by
    - a. Informing beneficiaries telephonically about the arrival of food.
    - b. Helped in distribution of food to people at 'Rahat Camp' by Government.
    - c. Helping create awareness to maintain Social Distancing during Food or Ration Distribution by Government Organizations.
  - Procedural guidance is provided to apply for 'Online Temporary Ration Card' by the Government.



d. CBR Sponsorship Program: It is seen that disabled children in slums are seldom respected, admired or accepted. ASRA took an initiative to promote the education of Children with Disabilities from its adopted slum communities at their post primary level. Parents are regularly counseled. This is an ongoing successful project running since August 2010.



207 Children with Disabilities (CwDs) have been sponsored under this program till date. They also received physiotherapy,

Occupational Therapy, special education, non-formal education, remedial education etc.

During the quarter under report, ASRA staff is in regular contact with 40 sponsorship children and their parents via Telephonic conversation. They are provided with different educational and recreational activities by ASRA teachers. **Sponsored children are also provided with study material kits and immunity boosters at their door steps.**

e. **CBR Vocational Training:** During the previous year i.e. April 2020 to March 2021, total 133 students attended online vocational training classes.

ASRA is running Inclusive Vocational Training / Skill Development Centres in Tailoring, Beauty Culture, Computer Courses and Mobile Repairing Courses in adopted slum communities. The training has empowered girls/ women and young boys to earn their livelihood. Those who have completed their training are now able to supplement their family income by taking jobs from their community members. Teachers are conducting online classes of Tailoring, Beauty Culture & Mobile repairing via telephones, Video calls and WhatsApp groups.

### **MEDICAL INTERVENTION & THERAPEUTIC SERVICES AT ASRA HEADQUARTER AND CBR**

# During the previous year i.e. April 2020 to March 2021, total 6016 sessions were provided digitally to 242 OPD patients and 34 children under AIRTC and total 6388 sessions to 278 PwDs from ASRA's adopted communities.

Initially, through online conferencing, all the therapists discussed a holistic approach to be followed with the patients. Patients have been divided amongst the Therapists according to the disabilities and diagnosis. Patients are guided about the exercises they can do by themselves at home. Therapists are telephonically resolving doubts of OPD patients regarding their exercise program. Therapy plans are made according to the need and disability of the children.

Videos and pictorials prepared by the therapists are sent to parents. Follow-up is done regularly with the parents. Exercises are being taught to patients / parents of children who don't have smart phones via phone call.

#### **Prosthetic and Orthotic Unit**

During the previous year i.e. April 2020 to March 2021, total 96 measurements have been taken for appliances and 55 appliances were delivered and fitted at door steps of the beneficiaries.

A feedback was received from CBR Therapists regarding urgent need to repair artificial limbs and requirement of new prosthetic and orthotic for some PwD beneficiaries. ASRA's Prosthetic and Orthotic Engineer along with the CBR Therapist paid home visits of PwD beneficiaries having urgent requirements and did the repair work of artificial limbs. Measurements has been taken Raw material has been procured for making new artificial limbs / mobility aids and is under process.



During the previous year i.e. April 2020 to March 2021, 7292 masks have been stitched by ARTC and CBR Tailoring staff. 355 orders were booked and 342 orders were completed by ASRA Emporium staff during last year.

**ASRA Handicraft Emporium** has been functional since April 2010. The Emporium is taking orders of stitching / alteration work and repairing of clothes etc. Due to lockdown, order work and stitching of mask was done by tailoring staff from home.

 Total 2771 masks have been stitched by ARTC and CBR Tailoring staff during the quarter under report. These masks are being distributed free of cost to the PwD beneficiaries and children of education, sponsorship and AIRTC programs. Masks are also being sold out to the interested customers.

#### SEED LOAN

The purpose of this program is to promote financial independence and help disabled persons living in slums to earn their livelihood and improve their quality of life. Seed Loan is given exclusively to the disabled beneficiaries of ASRA who are needy and want to be self-reliant. With the help of Seed Loan, they either purchase additional material for their respective enterprise or start a new enterprise which helps them to increase their monthly income. The total number of beneficiaries under Seed Loan program is 124. Seed Loan beneficiaries are provided with dry ration kit at their door steps.

## **NEW INITIATIVE**

ASRA initiated a vaccination drive to provide a safety shield to Persons with Disabilities living in its adopted community since they were trapped into a situation of helplessness due to unawareness and unnoticed attention. Many of the community members were struggling for survival and mental health. A focused campaign was planned to provide support to the PwDs to combat with the crisis of Covid-19 pandemic with awareness, counseling followed by vaccination. The PwDs covered under the vaccination drive have also been supported with Ration, Health and Hygiene Kits, Immunity boosters etc.

During the quarter under report 223 PwDs were vaccinated spread over in 23 communities. The ASRA vaccination drive stay continued.

During the quarter under report, a new initiative has been taken by ASRA to expand its CBR Activities in Noida, The National Capital Region (NCR). The underlying idea is to reach out to the newly identified and more and more needy persons with disabilities from economically poor section of society and replicate the existing CBR model with a view to educate, train and empower the needy educable, trainable and employable young girls and boys, men and women. Alongside, awareness about COVID appropriate behaviour and need for vaccination is also being highlighted by the CBR team. For expansion of this activity, a baseline survey is being organized in a newly identified slum community located in NOIDA, Uttar Pradesh State, to begin with. Most of the people are daily wage workers and factory workers. The process of hiring project office space has been initiated and need assessment of persons with disabilities covered under this survey is an ongoing activity. Some glimpses of the work undertaken in this new initiative are as follows.
